Aloha kākou,

As news of the fires on August 8, 2023, began to circulate, our ‘Āina Momona team knew we had to help. Having long been a partner to Hawaii Community Foundation, we were already aware of the Maui Strong Fund and knew it would be activated to support the people of Maui through this unimaginable tragedy. This was the first campaign we started for Maui relief.

In the days following the fires, we began to see the scope of the destruction and knew there may be more ‘Āina Momona could do to help. We began to develop other campaigns to provide immediate support to affected families and provide other support to stand up community-led recovery initiatives.

We have been privileged to play a role in the early days of response and recovery. ‘Āina Momona took no administrative fee for this effort. This report will serve as an accounting of how the funds we raised were distributed. We are looking to distribute all funds by the end of September.

We look forward to continuing to support the groups and organizations in West Maui who are revising and restoring their community.

This report is a work in progress. We will be adding to it as needed as we close and reconcile the various campaigns that we managed for Maui relief. Please check back for regular updates.
